

HARRISON TOWNSHIP TRUSTEE MEETING
December 17, 2024

REGULAR MEETING CALL TO ORDER:

Chairman Donnie Mayse called the Regular Trustee Meeting of December 17, 2024 to order with the Pledge of Allegiance at 5:00pm at the Harrison Township Fire Department, 3625 State Route 752, Ashville, Ohio 43103. Attending was Trustee Donnie Mayse, Trustee Jim Deal, Trustee Bill Welsh, Township Clerk Sara LeMaster, Operations Manager Austin Cline, Fire Chief Shawn Davidson, and Assistant Fire Chief Colt Cline. Absent was Fiscal Officer Lindsay Mayse. Visitors present were PIO Steve Sabine, firefighter Jeff Rosencrance, Mark Heister, and Walnut Township Trustees Wilson Ett and Warren Spangler.

FIRE CHIEF:

1. Chief Davidson asked the Trustees to accept the resignation of Peyton Weiler, effective January 9, 2025. Mr. Welsh made a motion to accept the resignation of Peyton Weiler, Mr. Deal seconded, and the Trustees voted with three affirmative votes to approve the motion.

Mr. Welsh moved, Mr. Mayse seconded, and the Trustees voted with three affirmative votes to approve R24-98.

RESOLUTION 24-99

A RESOLUTION TO ENTER A 12 MONTH CONTRACT WITH WALNUT TOWNSHIP FOR THE AMOUNTS COLLECTED FROM THE FIRE TAX LEVY WITH A MINIMUM OF 1.1 MILLION, WHICH WILL BE REEVALUATED IN 6 MONTHS. Mr. Welsh moved, Mr. Mayse seconded, and the Trustees voted with three affirmative votes to approve R24-99.
